Fulham Boys School is a Company limited by Guarantee and an exempt charity. It has 10 members who guarantee up to £10 in the case of the company being wound up. The Directors of the Company are appointed by the members and are known as the Trustees or Governors. They can appoint up to 10 Governors. The Governing body must consist of at least 2 parent Governors and the Headmaster. All Governors hold office for 3 years, except for the Headmaster who remains a Governor whilst in post. The company has 4 committees and the Governing Body can ask persons outside the Governing body to sit on these committees.
